Joint Transit Update

A motion by Deputy Mayor Nauss, seconded by Councillor Bain, "THAT Councillor Carver and Councillor Feeney be appointed as the Town of Mahone Bay representatives to the Joint Transportation Board, should the committee be re-activated." Motion carried.

NSUARB Board Order

Council received a copy of the Board Order from the Nova Scotia Utility and Review Board, approving the LED Street Light rate as requested by the Town of Mahone Bay.

Revised Solid Waste Management Bylaw #46

Deputy Mayor Nauss advised Council that due to a delay in advertising, the second reading of the Solid Waste Management Bylaw #46 will be considered at the January 25, 2018 Council meeting.

New Business

Uniform Assessment 2018/19

The CAO advised Council that the 2018 Assessment Roll has been received and that the Town of Mahone Bay has seen a 1.66% increase in the Universal Assessment Rate. Residential is up slighting higher than that and the commercial assessment has dropped slightly, a reflection of market values.

Resignation from Council

The CAO advised Council that he received correspondence from Councillor Chia-Kangata on December 2, 2017, submitting her resignation from Council as of December 31, 2017.

A motion by Councillor Feeney, seconded by Councillor Carver, "THAT Council receives the resignation from Councillor Simone Chia-Kangata as a member of Council, effective December 31, 2017, with regret, and that a letter be sent to Ms. Chia-Kangata thanking her for her service to the Town as a member of Council."

Mayor Devenne suggested that the Town pursue the opportunity of hiring a summer student as a way to provide employment for young people in the community and an opportunity for the Town to benefit from the ideas and enthusiasm of young people.

Council directed staff to pursue the application for the Canada Summer Jobs Program.
