a. Budget recommendation to Council

Because of Budget implications, this item was moved up on the agenda. Penny read out the 2016 proposal to encourage financial incentives for registered heritage property owners.

MOTION: Moved by Michael, seconded by Dell, that the 2016 HAC proposal to set up an incentive fund, for registered heritage property owners to access, be approved in principal and recommended to Council for budget consideration. The proposal is that a fund be established for an annual expenditure not to exceed \$10,000.00 for repair or restoration work on the exterior facade of registered heritage properties in the town of Mahone Bay. Private owners of

such properties would be eligible to apply for a matching grant of 50% of preapproved costs up to a total of \$2000.00 exclusive of HST.

b. South Shore Chapter of the NS Association of Architects

At this point, Gregory McNeil, President of the NSAA and Sharon Fogo of the South Shore chapter joined the meeting.

The Nova Scotia Association of Architects has formed a regional chapter on the South Shore, where there are 11 licensed architects. These are qualified professionals and could be available to provide public lectures on a mix of subjects, including heritage technologies. The NSAA promotes Architecture Week, the first week in October.

After some interesting discussion, an idea was floated about holding a one-day symposium on heritage architecture, to be held in October. Because Architecture Week would coincide with the Scarecrow Festival, a later date will be considered. The NSAA would help with promotion, social media, and will cover costs of their members' involvement. There was general support for this idea, and the HAC will discuss details at the March meeting, and meet again with the NSAA. If the plan goes ahead, HAC will extend an invitation to the NSCC Heritage Carpentry program to participate.
