### Mahone Harbour Water Quality

Mayor Devenne, along with Municipality of the District of Lunenburg (MODL) Councillor Michael Ernst, have requested that the Town and MODL jointly approach DFO and ask that they also test the ocean waters within Mahone Bay's inner harbour. Council agreed by consensus to coordinate with MODL to request increased testing by DFO.

### Community Connector Proposal

Council received a proposal from the Provincial Government and Maritime Bus for a daily bus service which would connect Lunenburg County to Halifax on a daily basis. As part of the proposal the Provincial Government requested the support of the municipalities.
