Call to Order the Chair called the meeting to order at 7:00 PM

Welcome – Deborah provided some background on the history of the committee and all members then introduced themselves. 3. Business Arising –

Deborah read an overview of the HAC activities in 2016:

The Heritage Advisory Committee held 7 meetings in 2016. Goals were set for the year in October 2015. At that time, these were:

- To register two properties these are still in the works.
- To sponsor one public information session Planning for this is ongoing.
- To meet with the Mahone Bay Museum to discuss ideas about fun ways to engage the public and feature heritage properties. This was the initiative of a former committee member, but interest waned after she left the HAC.
- To consider an appreciation process for good stewardship.
 - The HAC reviewed incentive programs in other municipalities in Nova Scotia and prepared and recommended a program to Council in June 2016. There is currently no budget for incentives so this initiative will stay on the 'back burner' for now.
- To respond to requests to alter existing municipally registered properties: A proposed addition to the registered property at 17 Aberdeen was recommended to Council in February, and the renovation of the bell tower at the Mahone Bay Centre was recommended in April.

a. Public Information Session

The committee will consider presenting a public information session, or Heritage Expo, with possible input from the NSCC Heritage Carpentry program.

Also, the NS Association of Architects newly formed South Shore chapter may be willing to give a public talk. Joe will check with the mayor to see where this stands.

b. Realtors & Heritage

Dell contacted the NS Real Estate Commission in Halifax last fall, and also the South Shore NS Realtors Association – contact person, Nicole Kreiger. It might make sense to include a public info session on heritage registration and resale at some point.

Dell would like to re-approach properties that are not registered but of heritage significance to the town. Deborah will circulate a list of those discussed in the last few years.
