## Canadian Drinking Water Guidelines

Health Canada has recently updated the Canadian drinking water guidelines for lead.



Public drinking water supplies in

Nova Scotia have been doing regular testing for lead for years, but now the new guideline limits for lead have been cut in half; from 0.010 mg/L to 0.005 mg/L as the maximum allowable concentration. We know exposure to lead in drinking water can cause multiple health effects on our bodies, so tighter limits are great news!

Although lead can occur naturally in geologic materials, the main source of lead in drinking water is through corrosion of plumbing materials with lead or brass components, such as pipes, solder, faucets, and fittings. The National Plumbing Code allowed lead material in pipes until 1975, in solder until 1986, and in fittings/faucets until 2013.

The Town of Mahone Bay continues to perform lead sampling and work with provincial regulators to ensure sampling protocols continue to meet regulatory requirements. The treatment process here adjusts the water's chemistry at the treatment plant to minimize the possibility of lead dissolving into the water, but additional steps can be taken at home.

# Budget 2019/20 Recap

On May 14, Town Council unanimously approved the 2019/20 budget - a budget derived from the updated Strategic Plan and the resulting Operational Plan for the town. The plans are driven by the insight of Council, federal and provincial legislation and needs identified by the citizens. Council has re-focused the work plan on the future development and direction of the town that this budget is intended to support. In spite of increased operating costs, the diligent efforts of the Council have provided a budget that balances the fiscal needs of the Town of Mahone Bay to meet its commitments and the responsibility Council has to the citizens.



#### 2019/20 Operating Budget Highlights include:

- Centennial initiatives with community partners including public celebrations and beautification projects in the downtown
- Additional steps toward a comprehensive asset management strategy, including infrastructure condition assessments and the establishing of a new Asset Management Advisory Committee
- The initiation of an update to the Town's Municipal Planning Strategy and Land Use By-law
- A shared service initiative with • neighbouring municipal units to streamline building and fire inspections
- Website improvements to improve ease of • access for the public
- A new public notification system
- Climate mitigation initiatives including a ٠ community Green House Gas emissions inventory, Active Transportation Plan, and initiatives to support solar energy generation and electric vehicle use
- Additional community engagement activities
- Continued commitment to build capital • reserves necessary for long-term asset management

#### 2019/20 Capital Budget Highlights include:

The Town also approved a Capital Budget including 30 capital projects totalling \$13.3 million over two years, supported by a projected \$7.5 million in external funding (56.4%).

Key investments in the 2019/20 capital budget:

 Several major water, wastewater and stormwater infrastructure improvements



- New equipment for the electrical utility and the Fire Department
- Renovation of the Town bandstand
- Plans for the replacement of the Town's aging fire station to accommodate newer, larger equipment and ensure the safety of our dedicated Fire Department volunteers
- Continued investment in recreational properties including the Town ballfield
- Edgewater Street shoreline improvement project – designed to protect Town infrastructure and community assets from the impacts of climate change

#### **Tax Rates**

The residential tax rate has increased from \$1.22 per \$100 to \$1.25 per \$100 of residential assessment. The commercial tax rate has increased from \$2.98 per \$100 to \$3.16 per \$100 of commercial assessment.


Infrastructure Charges have been set at \$275 per unit.

> The infrastructure charge is a uniform tax for all residents of Mahone Bay. Each dwelling unit/commercial space/lot is billed the infrastructure charge as part of regular property taxes.

The deed transfer tax will be set at 1.5%, effective August 1, 2019.

> The deed transfer tax is charged on dwelling units at the time of sale.

To reduce the impact of taxation, Council has also approved a low-income tax exemption program providing graduated tax relief ranging from \$100 to \$600 to qualifying taxpayers with household incomes under \$32,000. Information on the low-income tax exemption will be included with tax bills issued in July.




