Traditional Land Acknowledgement

Council received a staff report with recommendations regarding land acknowledgement and recognition statements.

A motion by Councillor Carver, seconded by Councilor Feeney, **"**THAT Council adopt the following acknowledgement that the Town of Mahone Bay sits on the traditional

lands of the Mi'kma'ki:

SHORT: Let me begin with our deep thanks to the Mi'kmaw people. We are gathered today in the traditional land of Mi'kma'ki, and we are grateful.

LONG: I wish to begin by acknowledging that Mahone Bay is in the traditional land of Mi'kma'ki. The municipality and all the peoples here are beneficiaries of the peace and friendship treaties with the Mi'kmaq. I extend to the Mi'kmaw people my respect and desire to build stronger relationships in the spirit and intent of these treaties. "

Draft Amended Outdoor Burning By-law

7.2 Town Logo

A motion by Councillor Carver, seconded by Councillor O'Neill,

WHEREAS at a regularly scheduled meeting of the Town of Mahone Bay Council on December 10, 2019 a motion was passed approving a new corporate logo, known as the Three Diamonds design; and

WHEREAS Council has heard expressions of concern about the design of Town's new corporate logo; and

WHEREAS some of these concerns indicate dissatisfaction that the process leading to Council's decision did not include public consultation; and

WHEREAS the Town has communicated to the public that the corporate logo will not replace the Three Churches logo on community signage; and

WHEREAS there will be opportunities for public engagement during the Wayfinding Consultation and the Municipal Plan Review which are scheduled to take place during 2020; and

WHEREAS Town officials will have an opportunity during the Wayfinding Consultation and the Municipal Review to highlight differences between place or community branding and corporate branding for a municipality; and

WHEREAS the Town of Mahone Bay's core values require us to be honest, accountable, fair, transparent and responsive,

THEREFORE be it resolved that, following the "community branding" public engagement component of the Wayfinding project and the "community vision" public engagement component of the Municipal Plan Review, Council will formally revisit its commitment to the use of the current Three Diamonds design as its corporate logo, with the understanding that the current Three Diamonds logo will continue to be used for corporate purposes in the meantime, while community signage will continue to feature the three churches. 2020-04-14_Minutes_Council_Regular
