5. GENERAL INVESTIGATION SECTION (Lunenburg County)

Constable Alexander Tucker is Lunenburg District's GIS Investigator. As a plain-clothes member he is responsible to investigate serious and/or resource intentive matters in conjunction with the SCEU Unit and/or MCU as required.

6. SCHOOL SAFETY RESOURCE OFFICERS (Lunenburg County)

Constable Ted Bailey is Lunenburg District's School Safety Resource Officer and is dedicated to providing support to Lunenburg County's 18 public schools. The SSRO works with local schools and delivers programs concerning a range of topics including cyber bullying, and other social media topics. With schools currently out for the summer Cst. Bailey has been assigned to a Watch to provide operational support to the District during the busy summer season.

7. COMMUNITY POLICING VICTIMS SERVICES OFFICER (Lunenburg County)

Constable Sonia Upshaw has returned to Lunenburg District following her assignment to the "H" Division Emergency Operations Centre (DEOC) where she assisted the with the coordination of quarantine monitoring and compliance within the Province. Based in Chester she is responsible for RCMP engagement with Community Groups and Victim Services.

8. CALLS FOR SERVICE

Between July 1st, 2021 and September 30th, 2021, Town of Mahone Bay had received 163 calls for service which included Criminal Code, Controlled Drugs and Substance Act, and Provincial Act Investigations.

SIGNIFICANT / NOTEWORTHY

Some significant and noteworthy items this past quarter include the following:

District Resources

- S/Sgt. Victor Whalen has taken command of the District.
- Sergeant Mark MacPherson is the operations sergeant working out of the Cookville Office.
- Sergeant Brent Johnston is the operations sergeant working out of the Chester Office.

• Cpl. John Payne is the RCMP's representative with the Towns of Lunenburg and Mahone Bay, Cpl. Payne will also supervise Lunenburg District's Community Policing Program.

Calls for Service

The attached chart gives a breakdown of the calls for service in this quarter. Some notable calls:

- July 13th, 2021 Motor vehicle vs motorcycle, the driver of the motorcycle was injured and taken by EHS to SSRH for injurues to be treated, the driver of the motorvehicle did not sustain any injuries and was issued a ticket under the motor vehicle act.
- August 14th, 2021 Lunenburg District members observed a female driver in the parking lot on Edgewater, illegally consuming cannabis behind the driver sseat of her vehicle. The female was charged in the form of a ticket, under the Cannabis Control Act.
- September 17th, 2021 Lunenburg District members attended to a complaint of a domestic disturbance in the town of Mahone Bay, upon police arrival, members identified and located a male, arrested the male for uttering threats, incidental to arrest, seized a pair of brass knuckles. The male was subsequently charged and the matter is before the courts.
- September 24th, 2021 Lunenburg District members were patrolling in Mahone Ba, observed a female driver speeding, vehicle pulled over, female driver arrested for impaired driving, charged, currently before the courts. Vehicle towed

10. STREET CRIME ENFORCEMENT UNIT & OTHER DRUG ACTIVITIES

The Street Crime Enforcement Unit is a three-member investigative unit integrated with the Bridgewater Police Service (2 RCMP Members and 1 Bridgewater Police Member) that is led by Cpl. Derek McAlpine of the RCMP. SCEU's mandate is to investigate low to mid-level organized crime and primarily investigates offences under the Controlled Drugs and Substances Act (CDSA) and Criminal Code.

11. TOWN OF MAHONE BAY

During the Third Quarter of 2021 there were 158 total generated occurrences in the Town of Mahone Bay. This includes all reported occurrences by the public, self-generated occurrences by police officers and traffic statistics including the Southeast Traffic Services which is not included in the attached Q2 statistics sheet.

Noteable occurrences were:

- During the Third Quarter a total of 18 Summary Offence Tickets were issued to motorists in Mahone Bay. Offences identified were primarily related to speeding, not wearing a seatbelt, insurance, inspection and registration violations as well as one cell phone ticket. In addition, 20 formal Warnings were issued as well.
- A total of 10 Checkpoints/Crime Prevention initiatives were completed in Mahone Bay during the Third Quarter. The majority of Checkpoints monitoring traffic compliance were a direct response to the increased complaints to the RCMP about traffic issues in the Town. Common areas checked with the new three way stop and Edgewater Street/Main Street where vehicles enter Town Limits.
- A total of 2 Federal Quarantine Act occurrences were created as well. Quarantine Act occurrences are created when an international traveler registers with CBSA at the border and identifies the community in which they will self-isolate. In addition to telephone checks, the RCMP may also attend in person to check compliance with self-isolation requirements. No violations were noted in any of the Quarantine Act files.
