Land Acknowledgement

Let us begin by acknowledging that we are gathered today in Mi'kma'ki. The ancestral, present and future territory of the Mi'kmaw people. Today, we gather with the intent followed by the living Peace and Friendship Treaties - with respect, cooperation and coexistence.

1. Agenda

A motion by Councillor Nowe, seconded by Councillor Carver, "THAT the agenda be approved as presented."

Motion carried.

2. Temporary Borrowing Resolution - Renewal

A motion by Councillor Feeney, seconded by Councillor Wilson:

WHEREAS Section 66 of the Municipal Government Act provides that the Council of the <u>Town of Mahone Bay</u> subject to the approval of the Minister of Municipal Affairs and Housing, may borrow to expend funds for a capital purpose as authorized by statute; and,

<u>WHEREAS</u> clause 66(4)(b) of the Municipal Government Act authorizes the Municipality to expend funds for the purpose of paying or retiring debentures;

BE IT THEREFORE RESOLVED

<u>THAT</u> under the authority of Section 66 of the Municipal Government Act, the Council of the <u>Town of Mahone Bay</u> borrow a sum or sums not exceeding <u>Two Million Seven</u> <u>Hundred Thousand</u> Dollars (\$2,700,000) for the purpose set out above, subject to the approval of the Minister of Municipal Affairs and Housing;

<u>THAT</u> the sum be borrowed by the issue and sale of debentures of the Council of the <u>Town of Mahone Bay</u> to such an amount as the Council deems necessary;

<u>THAT</u> the issue of debentures be postponed pursuant to Section 92 of the Municipal Government Act and that the Town borrow from time to time a sum or sums not exceeding <u>Two Million Seven Hundred Thousand</u> Dollars (\$2,700,000) in total from any chartered bank or trust company doing business Nova Scotia;

<u>THAT</u> the sum be borrowed for a period not exceeding Twelve (12) Months from the date of the approval of the Minister of Municipal Affairs and Housing of this resolution;

THAT the interest payable on the borrowing be paid at a rate to be agreed upon; and

<u>THAT</u> the amount borrowed be repaid from the proceeds of the debentures when sold.

Motion carried.

2. Closed Session

A motion by Councillor Burdick, seconded by Councillor Wilson, "THAT Council go into Closed Session at 12:10 pm to discuss contract negotiations as permitted by MGA section 22(2)(e)."
