### **AGREEMENT ON FINANCIAL SERVICES**

This Agreement is made this day of , 2024.

## **WHEREAS:**

The Town of Mahone Bay (TMB) and the Alternative Resource Energy Authority (AREA) each operate and support electrical utilities within Lunenburg County recognized and regulated by the Nova Scotia Utility and Review Board (NSUARB).

## **AND WHEREAS:**

TMB and AREA have a history of co-operating in many ways relating to providing services to customers of the utilities.

### THE PARTIES AGREE AS FOLLOWS:

For the purposes of this Agreement financial services shall be considered a contract service.

The Town shall provide AREA with financial services as defined in the attached Riverport Electric Light Commission (RELC)/AREA Utility Service Management Contract (specifically section 3.5 and "Schedule D").

AREA agrees to share in the costs of the Town's Finance Department in the amount of \$66,130 per year (increasing annually by NS CPI on April, 2025 and April, 2026), with additional cost-sharing - in excess of the services stipulated in the attached - on an hourly basis (\$50/hour for the Manager of Finance and \$35/hour for other staff) and additional financial system costs associated with this Agreement (Townsuite) split on a 50/50 basis.

ToMB agrees that AREA shall procure and manage a third-party contract resource (Karen Kluska) to facilitate the transition to the provision of steady-state Financial Services listed in Section 3.5 of the AREA/RELC Utility Service Management Agreement. The parties agree that a \$25,000 budget is reasonable for such third-party costs associated with the transition work.

The Town's Finance Dept. will be accountable to AREA for the provision of the defined services, in accordance with this Agreement.

This Agreement shall take effect Aprill, 2024 and continue until March 31, 2027. It may be terminated on the provision of three-months' notice by either party with annual costs to be pro-rated to the termination date.
