Solar Garden



Mahone Bay is investing in solar energy! In partnership with the Alternative Resource Energy Authority (AREA), we are developing a Community Solar Garden right here in Town!

This 1.873 MWpdc project will produce approximately 16% of the energy for the Town and will be located at the current wastewater treatment plant at 918 Main Street. 73% of the funding for this project will be provided from federal and provincial grants.

The Community Solar Garden will give all residents an opportunity to benefit from solar power and contribute to reducing our community's carbon footprint, while also providing the Town with a cost effective, stable energy source. Construction on the Community Solar Garden is expected to begin later this spring. For additional information, please visit community-solar.ca.



Tick Safety


Spring is in the air! We're all excited to get out and enjoy the spring weather but we need to remember that with the return of warm weather comes the return of ticks.


Nova Scotia has many types of ticks but the one of most concern for the spread of Lyme Disease is the blacklegged tick.








Message From the Mayor

Mahone Bay Town Council needs you!

The Municipal Government Act requires that Councillors be aware of the issues in their town and then to vote on an issue to be of benefit to the town in general. Councillors need information to support that level of awareness on the issues and on the perspectives of the citizens on the issue. This is where your Council needs your help.

We have citizen input on Council committees, and we value their input in making recommendations to Council. We have committees that deal with any number of topics and all the activity is invaluable to Council in helping the members to understand the issues along with concerns that citizens may have on a particular topic.

Council has garnered commentary from twelve citizens or groups on the strategic plan for 2021 to 2025. Responses from the citizens on the strategic plan will help hone our operational plans to achieve the goals we have established. And they will ultimately impact the budget and the tax rates and the level of service the town is able to provide.

Council may not always make decisions that appeal to every citizen, but everyone's input helps Council in honing their awareness on a topic and assists Council in determining the best action for the town as a whole. EV Chargers are Here!

Have you seen the Town's new electric vehicle chargers? Eight new level two chargers have been installed at Town Hall, Clairmont St, Main St, the Mahone Bay Centre, the Mahone Bay Civic Marina and the new Firehall! These electric vehicle chargers were installed as part of the Pan Maritime Provinces Municipal EV Charging Stations Initiative, with the goal of increasing electric vehicle charger access throughout the Maritimes. Since the transportation sector is the second highest source of emissions in Mahone Bay, installing electric vehicle chargers is an important step in reducing our emissions. Charging your electric vehicle in Town will truly allow you to reduce your carbon footprint, since our energy is already 84% non-emitting!

Our chargers will provide up to 30 km of range per hour of charging and will charge your vehicle 5 times faster than a standard home charger! They feature a universally compatible J1772 connector. There is a charge of \$1.50/hr to charge at these stations, which can easily be accessed using the FLO mobile application or FLO access card.

Municipal Boundary Review

The Nova Scotia Utility and Review Board (NSUARB) is required by the Municipal Government Act to conduct reviews of the number and boundaries of municipal polling districts and the number of councillors every eight years. Council will have to make a submission to the NSUARB, stating what Council composition should look like in the future, specifically:

Should there be polling districts?

Should Mahone Bay voters continue to elect people on a ballot with names from any part of town (like we do now) or should the town be divided into polling districts so that voters choose from candidates in a specific part of town?

Should Mahone Bay Town Council be made up of 4 Councillors + a mayor OR 6 Councillors + a mayor?

What do you think? Should Mahone Bay have six councillors or four?

- The Utility and Review Board will hold an independent Public Hearing in Mahone Bay before they make their decision
- The decision of the NSUARB will determine the make-up of Council at the next municipal election in 2024
